Dear Friend,

I am to inform you that you are invited to participate in 3 days Workshop on "Cultural Inputs in Curriculum Teaching" from April 6-8, 2015 at CCRT, 15A, Sector-7, Dwarka, New Delhi. This Workshop is organized specially for the CCRT trained teachers who act as CCRT's District Resource Persons and subsequently who will further acquaint 40-45 more in-service teachers from their own district and, if possible, from the adjacent areas by organising a 3 days short term workshop on "Cultural Education and CCRT's Role".

The Workshop will have the following objectives:

- highlight the need for aesthetic, culture and value oriented education so that the future generations become aware of their roots;
- to discuss the importance and also the reviewing of cultural education in schools;
- strengthening an understanding of the diversity of rich cultural heritage to promote right values;
- chalk out a plan for implementing methodologies and strategies for providing training to other in-service teachers.

Methodology and Work Schedule

We are envisaging discussion sessions with open ended intensive dialogue for spreading the understanding of fundamental principles of Indian Culture. The Workshop will have a chance to evaluate, review the present conditions of "Cultural Education in Schools" and devising of an action plan with the aim of implementing the CCRT's objective of "Integrated Approach to Education" in every school of our country. After successful participation as in the past, the CCRT would like to utilize your services as a 'Trainer' for spreading the understanding of fundamental principles of Indian Culture and making the teachers' community aware about it including the aims and objectives of the CCRT. You will be given a task (very important apropos to the approval/agreeing of your Principal and the District Education Officer/Inspector of Schools/Dy. Director of Public Instruction) of conducting a workshop further in your locality to train about 40-45 other in-service teachers of your area and neighbourhood so that we are one step closer in getting our cultural plurality embedded on the pedagogical practices. While attending this Workshop a framework of contents and methodologies drawn by us will be discussed with you so that you can organise a 3 days short term Workshop in your locality/district. The CCRT will give you the advance money to organise this Workshop.

I am very hopeful that it would be possible for you to take up this challenge. I am also sure that your Principal and the concerned District Education Officer/Inspector of Schools/DDPI will support you in completing this task as we occasionally remember your enthusiastic response in various activities while attending the training programme organized by the CCRT, and, of course, placing our confidence on you, the CCRT supports you. May I request you to please discuss this issue with your Principal and the concerned District Education Officer and if they agree identify minimum 40-45 such teachers from various schools who believe in the dictum that "A learning process visualizes education as a lifelong process" and this is equally applicable to teacher education. Please list the selected 40-45 teachers and their brief profiles in the scheduled form attached with your acceptance.

You will be requested to organise this 3 days short term Workshop in which halt at the venue for these minimum 40-45 selected teachers is not required. Consequent upon hearing from you, the CCRT will provide you the financial aid for organising this Workshop. Since lot of many other formalities will have to be completed for organising the workshop, we emphasize initially on agreeing of selection of minimum 40-45 teachers and get their approval from their Headmasters/Principals. As the District Education Officer also forms part of the team, we presume, you will have no difficulty in organising this Workshop.

Venue and timings:

The lectures and other sessions will be arranged at the auditorium of the CCRT, 15A, Sector-7, Dwarka, New Delhi. You would be required to attend the programme from 09.00 AM to 05.30 PM. The boarding and lodging arrangements have been made by the CCRT. The details regarding boarding and lodging arrangements can be seen at Annex I. No relatives members of the family/escort will be entertained at the place where boarding & lodging arrangements have been made by the CCRT for her participants due to paucity of space and other administrative reasons and no permission for their stay (of relatives, escort, etc.) will be provided under any circumstances.

Separate arrangements will be made for the female teachers at the hostel.

**We have to hear your affirmative response with regard to the following Mandatory requirements:**

- If you have retired or retiring within 2-3 months, please treat this letter as cancelled and do not report for participation in this training programme and at the same time, you are requested to inform CCRT accordingly.
- The allocated budget for organizing of 3 days short – term workshop is Rs 29000/- to train 40-45 teachers.
- Certify that you will spend the advance money for organization of the 3 days short term workshop as per the budget provision of CCRT, mentioned in Expenditure Statement. No extra reimbursement will be made by the CCRT in this regard.
- Certify that you have received the approval of your Principal and the DEO to support you in organising this workshop; (Ref. Annex II).
- Certify that you accept the challenge of organizing 3 days short term workshop at your school preferably till June, 2015 and prior to that attendance in 3 days short term workshop from April 6-8, 2015 at New Delhi. It would be convenient for both of us if you could bring the confirmed dates of 3 days short term workshop approved by the D.E.O. and your Headmaster/ Principal along with you as we will be able to release the advance money through Electronic Clearing Services (ECS) along with other material during the Workshop at New Delhi. The required information related to ECS is desired as per Annex III.
- Certify that you have identified and selected 40-45 other in-service teachers teaching in govt. and govt. aided Schools; less than 50 years of age, (Ref. Annex IV). You may bring



- the list of these 40-45 teachers with you. Please also ensure that not more than one teacher should be selected from one school.
- Certify that you accept the challenge of organising 3 days short term Workshop at your school preferably till June, 2015. An undertaking to this effect is enclosed (Annex V)
